The InMotion Network is an organization that aims to remove barriers for individuals who have been, and continue to be, underserved by our sport, recreation, and physical activity systems.

## **Director Requirements**

- Must have, or be willing to purchase, an InMotion Network Membership
- Normally reside in Alberta
- Have a significant interest in the development of women's sport, leadership, recreation or physical activity in Alberta.

## **Director Responsibilities**

As a Director of the InMotion Network, your role is to support the interests of women and girls so that they have the opportunity to meaningfully participate, as leaders, coaches, officials, athletes, participants and administrators in the sport, physical activity and recreation sector.

This is done by working together to remove barriers for individuals who have been, and continue to be, underserved by our sport, recreation, and physical activity systems.

Directors, individually and collectively as the Board of Directors are ultimately responsible for the operation and affairs of the InMotion Network (IMN) and required to participate in the deliberation and decisions in governance matters.

It is desired that the Board of Directors represents a broad spectrum of interests and stakeholders and that they will be elected based on their participation and involvement in sport, leadership, recreation and physical activity in Alberta, and most importantly their support of the mandate of the InMotion Network. Given this, those seeking to be Directors of the InMotion Network should have relevant leadership within one of the sport, recreation and/or physical activity sectors. They should be individuals who are committed to attending all or most of the Board's meetings and actively participate, and to be willing to represent the InMotion Network on ad hoc and standing committees whether they are internal or external in nature.

## **Term of Office:**

A Director being elected, as per the Bylaws, shall hold office for a 2 year term with the ability to renew for a total of 4 terms.

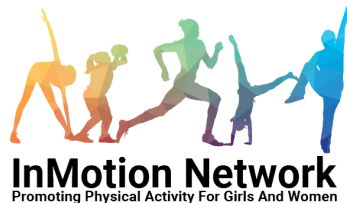
